## Minutes of the meeting of Bampton Town Council held on Monday 3rd June 2024, 7pm in the LARC

- 1) Apologies and Acceptance for Absence: District Cllr. Gilmour. Cllr. Whiteway. Apologies accepted.
- 2) Declarations Of Interest: In accordance with the Code of Conduct, members are required to declare any personal or disclosable pecuniary interests, including the nature and extent of such interests they may have, in items to be considered at this meeting. Members are also reminded that any change to their Declaration of Interests must be notified to the Monitoring Officer at Mid Devon District Council within 28 days of the change.
- **3) Public Discussion** To allow any questions, reports by members of the public on any matters relating to the agenda of this meeting or any matters the public would like the Council to consider on a future agenda. The period of time designated for public participation shall not exceed 30 minutes. Standing Order 3 (e,f.) refers.

Parishioner about the state of Bampton with weeds and overgrowth within the Town. Considers visitors would not like the town as it is. Cllr. Fouracres informed that the grass contractors cut the grass that belongs to the parish. The grass in Barnhay is the responsibility of Mid Devon Council – passed to Cllr. Binks for action.

**4)** Chairman's Report (for information only) – Member of the public has asked what is happening to the leat in Brook Street. Discussed and in the first instance to be taken to Highways. Discussed with another contractor about installing the island, but no quote as yet received. A lamp to light at the war memorial a 'D' Day red lamp of peace to be lit at 9.15pm on the 6<sup>th</sup> June. It will be left overnight and collected on the Friday. Town crier will do a 'cry'. Gather at the war memorial at 9pm.

#### 5) County & District Councillor reports -

Report submitted by email earlier today. Cllr. Adcock elaborated on some items in the report. Cllr. White requested raising the issue of the road surface from the Exeter Inn towards Tiverton, being very rough.

- 7) Toilets to consider a parish wide survey on the toilets. Cllr. L. Bull to report. Postponed.
- 8) Play areas
  - i. To consider Mid Devon Council as a regular contractor to check the playgrounds (3). Costs are as follows £84 for one, £50 for the second and £25 for the third, so £159 + VAT per inspection, whether it is monthly (recommended) bi-monthly and so on. Discussed.
    Cllr. Fouracres proposed go ahead with use of Mid Devon as a regular contractor bi-monthly. All agreed by show of hands. Clerk to action.
- 9) Charter Fair to receive an update from the latest Charter Fair Committee meeting. Cllr. White reported that a main act is still work in progress. Thanks to Ed Tanner for organising the music. Received a

£1000 Locality Grant towards the marquee for the childrens area. County Cllr. Chesterton has been thanked for actioning this grant.

**10) Bampton Hall** – to receive an update from the Hall Committee meeting held on 23<sup>rd</sup> May. The proposed meeting for the community on 28<sup>th</sup> June cannot now go ahead in the Community Hall. Now suggested a Saturday morning stall, in Brook Street, 22<sup>nd</sup> June, 9.30-12.30pm.
